

UKFP 2024: Allocation to Foundation School

Key Points and FAQs

Below is a summary of key information about the Preference Informed Allocation process that took place on 7th March 2024, and answers to frequently asked questions.

Allocation information

All eligible applicants to the 2024 Foundation Programme were allocated to a foundation school on 7th March 2024. Applicants received a notification email from Oriel (which was sent to the email address that is registered on their account) with the details of their allocation. Applicants can also view their allocation result directly on Oriel by logging in to their account.

Can I find out what my rank is?

The computer-generated rank that applicants receive is not visible on Oriel. Applicants will not be informed of their individual rank until after the programme matching process is completed for all applicants in July 2024. Removal of EPM/decile and score

Due to the introduction of the Preference Informed Allocation process and a computer-generated rank the EPM/decile score is no longer used for application to the Foundation Programme and has been removed from the FP2024 application process. Medical schools no longer produce decile scores for use in the application process, and therefore an applicant’s computer-generated rank is not informed by performance at medical school.

Can I appeal my allocation result ?

No, it is not possible for an applicant to appeal against their allocation. Allocations to foundation schools are final and cannot be changed. Refer to the national appeals guidance on the UKFPO [website](#).

Why have I been unlinked from my linked partner? We have been allocated to different foundation schools.

The link will have been broken if:

- there weren't two places available in any foundation school/UoA at the point that the allocation algorithm attempted to place the linked applicants in the same foundation school/UoA.
- either you or the other applicant has been pre-allocated to a particular foundation school/UoA.
- either you or the other applicant has accepted an SFP or FPP offer
- one or both of you has not preferenced the foundation schools/UoAs in the same order as each other

Can I swap my allocated place with another applicant?

Once allocated to a foundation school (and to a programme) there is no system for swaps between foundation schools or within individual foundation schools and programmes. Swaps will not be facilitated by the UKFPO or by Foundation Schools under any circumstances.

Withdrawing an FP application

Applicants are advised to discuss their circumstances with their medical school (or allocated foundation school) before withdrawing their application to ensure that the consequences of doing so are understood.

If you decide to withdraw from the recruitment process you will not be able to rejoin the current recruitment round and will be required to re-apply for the Foundation Programme the following year. You are advised to read the declarations stated on the 'declarations' page of your submitted application form carefully, to fully understand the implications of withdrawing applications part-way through the process.

Provisionally registered doctors are not permitted to undertake alternate employment as a doctor or work as a locum outside of the recognised and GMC approved Foundation Programme in the UK.
