### **Executive Summary**

The UK Foundation Programme Office (UKFPO) coordinated a national process for recruitment to F2 Stand-alone programmes commencing in August 2021.

Wales were included in the recruitment process for F2 Stand-alone programmes this year. Except for 2021 and 2018, historically, Wales have opted to recruit to Locum Appointment to Service (LAS) posts if necessary.

The selection process for F2 Stand-alone recruitment changed for 2021. Applicants were required to sit the Situational Judgement Test (SJT) as part of the application process and were selected for one of the following depending on their SJT score:

- a. Interview bypass offered a post without interview (those who scored highest in the SJT)
- b. Interview invited to attend online interview (outcome of interview will be appointable/not appointable)
- c. Not invited to interview withdrawn from the process (those who scored lowest in the SJT)

Applicants in group a, and those deemed appointable in group b, were ranked by their SJT score (instead of interview score) and offers were made based on this rank.

A total of 1140 applicants applied, 684 of whom sat the SJT. Of the applicants who attended the SJT, 98 bypassed the interview and were offered a post and 410 attended the interview. The process yielded an overall fill rate of 90.24%. Of the 1140 applicants who applied, 388 received offers, 41 of whom either declined or let their offers expire. A total of 13 applicants originally accepted offers which they later withdrew from.

At the end to the process, 333 new appointments were made, that is, to external applicants and not those currently working as part of a two-year programme. A total of 36 F2 posts remained unfilled at the end of the process.

## **Background/Introduction**

Every year there is a significant cohort of applicants who are not eligible for entry to the foundation programme at F1 level as they hold full registration with the General Medical Council (GMC), but are too inexperienced in either the NHS and/or a clinical setting to apply for specialty training.

Historically, recruitment to F2 Locum Appointment to Training (LAT) posts has typically been conducted by individual foundation schools.

In 2016, NHS Education for Scotland (NES), Health Education England (HEE) and the Northern Ireland Medical and Dental Training Agency (NIMDTA) recruited applicants with full registration to unfilled F1 training posts. In 2017, the UKFPO administered a national process for recruitment to F1 stand-alone posts and foundation schools assumed responsibility for local/regional interview centres and managed their own recruitment processes for F2 stand-alone.

The UKFPO led a national process for recruitment to F2 Stand-alone programmes to commence in August 2018, 2019 and 2020. Applicants were invited to attend one interview if they chose to apply for the F2 Stand-alone programme.

This year (August 2021 start), F2 Stand-alone programmes were recruited to nationally by the UKFPO. Due to COVID-19, all interviews were conducted online (via Skype) with applicants and panel members interviewing remotely from their location. For 2021, there was an expansion at F2 level across England, largely to support the intake into GP training in line with the Health Education England People Plan and there were an additional 249 new F2 posts in England as a result. Health Education and Improvement Wales (HEIW) also took part in F2 Stand-alone recruitment this year.

## **F2 Stand-Alone Programmes**

All Stand-alone posts are recognised training posts with equivalent educational supervision and access to the foundation e-portfolio. Trainees are offered the same development opportunities as those completing F2 as part of a two-year programme. Stand-alone training posts are fixed-term for one-year.

## **Applications**

All applications for F2 Stand-alone programmes were submitted and managed through the national online application system (Oriel). A total of 1140 were submitted for F2 Stand-alone programmes due to commence in August 2021.

A total of 261 UK nationals who graduated from overseas medical schools applied for F2 Stand-alone programmes. Due to the restrictions lifted by the UK government, applications were not subject to Resident Labour Market Tests (RLMT).

# **Eligibility/Longlisting**

Applications were longlisted by the UKFPO against the eligibility criteria for F2.

Of the 1140 applicants who applied for F2 Stand-alone, 2 withdrew their applications before the longlisting process, leaving **1138** applications.

### **Situational Judgement Test (SJT)**

#### **SJT Sittings**

Applicants who were successful at the longlisting stage were invited to book SJT slots via the Pearson Vue system. Applicants were given the option of sitting the test in a Pearson Vue test centre, or at home via online proctoring. Of the 749 applicants who were invited to sit the SJT, 684 attended.

#### **SJT Outcomes**

The selection process for F2 Stand-alone recruitment changed for 2021. Applicants who sat the SJT were selected for one of the following depending on their SJT score:

- a. Interview bypass offered a post without interview (those who scored highest in the SJT)
- b. Interview invited to attend online interview (outcome of interview will be appointable/not appointable)
- c. Not invited to interview withdrawn from the process (those who scored lowest in the SJT)

#### **Interview Bookings**

The 452 applicants in group b (above) were invited to book interview slots on a first come first served basis through Oriel.

#### **Interview Attendance**

A total of 410 applicants attended an interview for F2 Stand-alone foundation posts across three interview days. Applicants only attended one interview.

#### **Interview Outcomes**

Of the 410 applicants who attended the interviews via Teams, 311 applicants were deemed appointable. Including the 98 applicants who bypassed the interview, **409** applicants were deemed appointable in 2021, compared to 418 in 2020. 5 applicants withdrew before the offers process, and therefore 404 applicants progressed into the offers process.

## **Offers**

All offers were made through Oriel on a meritocratic basis (using SJT score). There were two initial rounds of offers and two clearing rounds for the F2 Stand-alone programme.
