

### Nomination & Registration

#### UK graduates are nominated by the medical school

Applicants who qualified or are expecting to qualify from a UK medical school after
 3 August 2021 and by 3 August 2023 are nominated by their medical school

#### You will receive an email inviting you to confirm your nomination

- You must not create an account on Oriel (only use nominated information from medical school). Please use the link emailed to you to register on Oriel.
- You must confirm your nomination (click the link in your email 'Nominee Confirmation required'). If you do not receive this email, contact your medical school immediately
- You must register with the email address your medical school used to nominate you with
- Military applicants are not required to apply via Oriel (contact Defence Deanery for details)

- One all-encompassing application form, so applicants will only submit one main application form that will include:
  - The option to apply for specialised foundation programmes (SFP) as well as FPP (Foundation Priority Programmes)
  - Pre-Allocation for Personal Circumstances requests
  - SJT Reasonable Adjustment requests

# Key Changes for 2023 - Educational Achievements (EAs)

Educational achievements have been removed from the main FP application and scores are no longer awarded for these within the main FP score (this is now decile score + SJT score)

However, educational achievements remain part of the application process for SFP selection in some Specialised Units of Application. Information will be available on individual foundation school websites.

# Situational Judgement Test (SJT)



- The SJT is a measure of meeting the attributes required to be a foundation doctor, as defined in the national FP personal specification
- > It is not an assessment of your clinical knowledge
- All applicants are required to sit the SJT, including SFP and FPP applicants and Defence Deanery/military applicants.
- Reasonable adjustments
  - must be requested at the time of application (on the main application form)
- Extenuating circumstances
  - Must be claimed within one working day of the SJT sitting you were registered for
  - Cannot be claimed if you have taken and completed the test

### SJT – What to expect



- Invigilated test
- Take the test from home (online) or at test centres all over the world
- > ID checked
- No smart watches, no pens/pencils, no papers
- ➢ Scores marked national and translated to a 0 − 50 point scale
- Practice papers and resources available on UKFPO website

## **Linked Applications**



- Both applicants must preference UoAs in the same order
- Linking is only possible for FP (and not for SFP or FPP)
- Links will be severed if:
  - a) Either or both accept an SFP or FPP programme
  - b) Either or both applicants are not placed on the primary list
- Both applicants must be allocated to the primary list
- Allocated to school according to score of lower ranked applicant
- Local foundation school programme matching policies vary at group/programme level

### Pre-allocation



- ➤ The criteria for **pre-allocation based on personal circumstances** for UKFP
  2023 are:
  - 1. Parental/guardian responsibilities
  - 2 a). Primary caring responsibilities
  - 2 b). Significant caring responsibilities >
  - 3. Medical condition
  - 4. Unique circumstances
  - 5. a) Educational circumstances
    - b) Widening participation
- Applications via Oriel
  - Pro-forma required (found on UKFPO website)
  - Evidence (completed form and supporting documents) required

to be uploaded to Oriel

- Circumstance must be relevant at the time of application
- Requested foundation school must be ranked <u>first</u>
- Not applicable for SFP, FPP
- Applicants cannot link
- Applications will be considered by a national panel

You must score highly enough to be placed on the primary allocation list (pre-allocation will be honoured if possible but is not guaranteed for applicants who are not placed on the primary list)

### **National Allocation**

- Applicants will be allocated in rank order (meritocratic – highest rank allocated first)
- If all the places are filled at your first choice foundation school, the system will consider your second preference, and so on down your list of preferences until a space is available
- Linked applicants will be allocated based on the score of the lower ranked applicant of the pair



#### **Primary List**

Allocation to a Foundation School (UoA) takes place in March 2023

## Specialised Foundation Programmes (SFP)



- Academic/research, education and teaching, and leadership and management
- Explore academia/education/leadership as a career at the same time as developing your clinical and generic skills
- 'Academic' or specialised supervisor
- All FP applicants eligible to apply, if you're interested!
- ➤ Information and programme descriptions for SFPs can be found on local Foundation School websites.

### SFP Selection



- Applicants will need to apply to each SUoA (up to a maximum of two) in part 2 of the main FP application form.
  - "Specialised Unit of Application" (SUoA)
  - White space questions (used by some, but not all SUoAs)
  - Educational achievements (separate and not included in main FP)
- SUoA selection process determined locally.
- Submit SFP applications as part of, and at the same time as your FP application
- ➤ All SFP offers are subject to a satisfactory SJT score

# SFP - General Information



- ✓ Highest scoring SFP applicants will receive offers first
- ✓ If higher scoring applicants decline these offers, they will then be offered to lower scoring applicants
- ✓ Familiarise yourself with the SFP offers timetable which can be found on the UKFPO website
- ✓ All SFP offers are <u>subject to a satisfactory SJT score</u>
- ✓ If you accept an SFP offer, you are excluded from the FP allocation
- ✓ If you do not secure an SFP post, you will be included in the FP allocation automatically

## Foundation Priority Programmes (FPP)



- Incentives for these posts include financial benefits, unique teaching and leadership opportunities and specialty experiences (please look on foundation school websites for details)
- Select in main application form if you wish to be considered
- Rank individual programmes
- Offers to individual programmes before national allocation to foundation schools
- If you accept an FPP offer, your FP application will be withdrawn



# Psychiatry Foundation Fellowships (PFF)

The application and selection process for PFF programmes is currently being reviewed and information will be available in the main FP applicant guide which is due to be published in July 2022.

# Supporting Trainees Entering Practice (STEP)



- Supports transition from medical school to foundation training; two-way transfer
- Health and welfare, educational progress and professional performance, and patient safety
- Students complete STEP form online
- Medical school endorses information.

The information you provide in your form is used to **support** you during your training and is <u>only</u> shared with your Foundation Training Programme Director/FP Co-ordinator (and anyone else that you give permission for it to be shared with).

## **Employment**



### **Employer Responsibilities: -**

- Pre-employment checks, including occupational health and reasonable adjustments
- References
- Pay
- Pension
- Rotas
- Contract of employment
- Accommodation (if applicable)
- Shadowing and Induction programme/timetable

Do not leave your registration and application to the last minute! Late applications are not accepted under any circumstances
